

F-1 International Student Financial Statement

International Students who are admitted into a degree program at Rutgers, the State University of New Jersey must obtain a Certificate of Eligibility (Form I-20) to enter and/or remain in the U.S. as an F-1 student. This requirement applies both to international students coming from abroad and F-1 students transferring from another U.S. education institution.

For Rutgers to issue you a Form I-20 you must submit:

1. This form with both Section One and Section Two completed, including signatures from both you (the student) and your sponsor.
2. A copy of the picture page from your passport.
3. **Original** bank statement(s), on bank letterhead, from you or your sponsor, issued no earlier than *nine months* of the date you intend to begin your studies. For students beginning in the fall (September) semester, we cannot accept any bank statement issued before January 1. Account balance(s) must be shown in an amount greater than or equal to \$48,000 USD. (*Faxes and photocopies are not acceptable.*) **Note:** Bank statements must be for a checking, savings, or time deposit account. Brokerage (stock funds), real estate, or any other non-liquid assets are not acceptable.
