ANNOUNCEMENT

Re: Some urgent prevention & control measures of COVID-19 at International University

Based on Decree No 05/CT-TTg dated Jan 28, 2021 from the Prime Minister of Vietnam regarding urgent prevention and control measures of Covid-19;

Based on Announcement No 67/TB-VP dated Jan 28, 2021 from HCMC People's Committee and the conclusion by HCMC People's Committee Deputy Chairman Võ Văn Hoan at HCMC Covid-19 Taskforce's conference;

Based on Decision No 79/CT-BGDĐT dated Jan 28, 2021 from Minister of Education and Training regarding some urgent prevention and control measures of Covid-19 within educational institutions;

Based on Document No 136/ĐHQG-VP dated Jan 30th 2021 from Chancellor of VNU-HCM regarding prevention and control measures of Covid-19.

International University Board of Management has issued the following mandates applicable to all IU Schools, Departments, Offices, and Centers:

1. Strictly follow the 5K guidelines: wearing masks, washing hands, distancing, limited gathering, medical declaration;

2. Faculty, staff, and students are encouraged to limit their travel, especially to COVID-19 stricken areas. Those who return to HCMC from COVID-19 stricken areas in the past 14 days are to report to their immediate managers and make medical declaration to the authorities;

3. Faculty and staff are encouraged to make use of ICT in their work. Faculty members should get ready to switch virtual teaching when needed and keep students informed about this switch in a timely manner;

4. The Schools, Department, Centers, Offices are requested to keep track of their people's movement to and from the COVID-19 stricken areas, including Hải Dương, Hà Nội, Quảng Ninh, Hòa Bình, Bắc Ninh, Bình Dương (Phú Giáo), Gia Lai, Hồ Chí Minh City (District 11), etc. Lists of affected faculty and staff are to be sent to IU Department of Human Resource at tccb@hcmiu.edu.vn. Lists of affected students are to be sent to IU Office of Student Services at corona@hcmiu.edu.vn;

5. All social gatherings, parties, festivals, etc. are postponed until further announcements are made;

6. All units continue to implement the prevention and control measures of COVID-19, such as: having staff and students wear masks on campus, checking

temperature, washing hands, cleansing corridors, classrooms with disinfection liquids, etc;

7. Office of Undergraduate Academic Affairs, Office of Graduate Affairs, Office of Student Services, and all other schools and departments are to communicate these messages to their lecturers, staff, and students.
